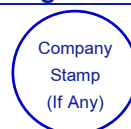

Description for FTI Membership Type

1. Ordinary Member (OC)

- ✚ A legal entity established under Thai law and engaged in manufacturing industry, which classified into two categories as follows:

Group 1: has machinery with more than 50 horsepower

- ✓ Hold a factory operation permit under the Factory Act (Ror Ngor.4) / Letter of Permission for Land Utilization and Business Operations in an industrial estate under the Industrial Estate Authority of Thailand Act B.E. 2522 (1979) (IEAT).

Group 2: no machinery or has machinery with less than 50 horsepower.

- ✓ If the factory operation permit is not available, the assessment will be based on the Thailand Standard Industrial Classification (TSIC) code registered with the Department of Business Development, which demonstrates its relevance to the industry. The additional evidence required includes:

- Photographs of machinery, equipment, production process, and production location
- Documents issued by government agencies showing production (if any)

2. Associations Member (AM)

- ✚ A trade association established under the law governing trade associations, with the objective of promoting industrial operations.

3. Associate Member (AC)

- ✚ A legal entity established under Thai law and engaged in trade or service business, but not involved in manufacturing.

4. Individual Member (IC)

- ✚ An individual not registered as a legal entity.
